"Mandatory" arbitration clauses refer to contractual provisions that deem arbitration the exclusive remedy for resolving disputes, as opposed to "voluntary" arbitration provisions which allow shareholders to elect litigation in court.

Clause for simple arbitration: Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules [including the Optional Rules for Emergency Measures of Protection].
